Attendance Boundary Description

NORTH:

Start at the Brevard / Osceola County line at a point West of the intersection of John Rodes Blvd. and Ellis Rd.,
East from this point to the intersection of John Rodes and Ellis,
South on John Rodes to Sheridan Rd.,
East on Sheridan to Wickham Rd.,
South on Wickham to US 192 (New Haven Ave.),
East on US 192 to a point East of Cannova Dr., and the East boundary of the East parcels East of Lee Rd.

EAST:

South from this point on an imaginary line to Henry Ave.,
East on Henry to a point in line with the West boundary of the West parcels on the West side of Park Hill Blvd.,
South on these property lines to the Canal between Buffalo St. and Chica Circle,
South on this Canal until it turns East,
East on this Canal to Dairy Rd.,
South on Dairy to Eber Blvd.
East on Eber to the point it turns North Before Minton Rd.,
East from this point to Minton,
South on Minton to I 95,
South on I 95 to Palm Bay Rd.

SOUTH:

West on Palm Bay to Minton Rd.,
West from this intersection to the West end of Canal Number 66,
West on Canal 66 to a point South of the South end of Powell Rd.,
South from this point to a point that is the West boundary of West parcels on the West side of Heide Ave. and the East boundary of the East parcels East of Furth Rd.,
South from this point to Emerson Dr.,
South from this point to the North-West boundary of the Air Force Eastern Test Range (Malabar Annex.),
South on the West boundary of the Malabar Annex. to the South-West boundary of the Malabar Annex. and Canal Number 1,
West on Canal 1 to Jupiter Blvd.,
North on Jupiter to Canal Number 68,
West on Canal 68 to a point that is West of the West boundary of parcels West of Camden Ave. and East of the East boundary of parcels East of Lamplighter Dr.,
From this point North to Canal Number 67,
East on Canal 67 to Jupiter Blvd.,
North on Jupiter to Canal Number 66,
West on Canal 66 to Canal Number 10,
North on Canal 10 to the Canal that is South of Ranch Rd.,
West from this point to the Brevard / Osceola County line.

WEST:

North on the Brevard / Osceola County line to Start.

Satellite Area:

NORTH:

Start on Grant St. at a point West of the intersection of Church St. and Race St.,
East from this point to the intersection of Church St. and Race St.,
East on Church to Lipscomb St.,
South on Lipscomb to Mill St.,
East on Mill to Main St.,
North on Main to Jernigan Ave.,
East on Jernigan to the Florida East Coast Railroad.

EAST:

South on the FEC Railroad to University Blvd.,
West on University to Lipscomb St.,
South on Lipscomb to Florida Ave.

SOUTH:

West on Florida to Aldrin St.

WEST:

North on Aldrin to Redbud St.,
North from this intersection to the intersection of University Blvd. and Grant St.,
North on Grant to Start.
